## 1. Introduction

**Cookies & Similar Technologies:** cookies, pixels, SDKs, and local storage used for authentication, analytics, preferences, and performance.

## 3. How We Use Information

- Provide, operate, and improve the Services;
- Personalize content and features;
- Process payments and fulfill purchases;
- Communicate about updates, security alerts, and support;
- Monitor usage, perform analytics, and prevent fraud;
- Enforce our terms and comply with legal obligations.

## 4. How We Share Information

We do not sell your personal information. We may share it with: (a) service providers (hosting, analytics, customer support, payment processing) bound by confidentiality; (b) authorities or third parties when required by law or to protect rights, safety, and property; and (c) entities involved in corporate transactions (merger, acquisition, reorganization), subject to appropriate safeguards.

## 5. Legal Bases for Processing (Where Applicable)

We rely on one or more of the following: performance of a contract; legitimate interests (e.g., to secure and improve Services); consent (for certain marketing or cookies); and legal obligations.

## 6. Data Retention

We retain personal information for as long as needed to provide the Services, comply with legal obligations, resolve disputes, and enforce agreements. Retention periods vary by data type and purpose.

## 7. Data Security

We implement administrative, technical, and physical safeguards designed to protect personal information. No method of transmission or storage is completely secure; we cannot guarantee

absolute security.

## **8. International Transfers**

Your information may be transferred to and processed in countries other than your own. Where required, we implement appropriate safeguards for cross-border transfers.

## **9. Your Privacy Rights**
